## **Personal Information Consent**

It has been agreed that Pili Fan Club (PILI INTERNATIONAL MULTIMEDIA CO., LTD.) is entitled to collect, process and utilize your personal information as permitted by law and as per purpose, duration, location, objects and method stated below:

### **I. Purpose of personal information collection:**

#### **(I) Provision of services:**

Manage member information, post monthlies and Pili Fan Club gifts, provide product information by e-mail or monthly, provide privileges, or inquire, calculate, verify, record and decide whether members enjoy rights and interests, present gifts, conduct internal statistical survey and analysis as well as marketing, launch e-paper of related activities, online shopping and other e-commerce services.

#### **(II) Organization operation requirements:**

Deposit/payment/remittance, account/tax administration, inspection/audit or other needs business registration or business in relation to regulations etc.

### **II. Type of personal information collected:**

(I) Identity information: name, profession, contact information and education etc.

(II) Financial information : account number of credit card or Debit Card, other financial codes or accounts etc.

(III) Personal description; age, gender or date of birth.

(IV) Official documents: ID card number or passport number.

### **III. Duration, location, object and method of personal information utilization**

(I) Duration: period of existence of personal information collection purpose. Personal information stipulated by law, required by service execution or as to a written consent of member shall be excluded.

(II) Location: Taiwan and where you are located.

(III) Object and method: Pili Fan Club and affiliated enterprises of Pili Fan Club (including but not limited to DAPILI INTERNATIONAL MARKETING CO., LTD. and PUPPETMOTION ENTERTAINMENT CO., LTD.), third parties licensed to handle business affairs (such as partners and logistics companies), and other processors of organizations collecting, processing and utilizing personal information as stipulated by law for the purpose of marketing and collection and by reasonable methods.

IV. Pursuant to provisions of law, member needs to inform Pili Fan Club by post or dial service hotline of Pili Fan Club (+886 05-622-4366) and consequently is entitled to exercise the following rights:

(I) Inquire, request to read or prepare copies, Pili Fan Club will collect the cost according to law.

(II) Request to supplement or modify only proof materials in relation to contents to be supplemented or modified as required by Pili Fan Club as appropriate.

(III) Request to stop collection, processing or utilization or request to cancel.

V. In case that personal information cannot be provided or false personal information is provided, Pili Fan Club will be unable to provide services in relation to 「I. Purposes of personal information collection」 .
